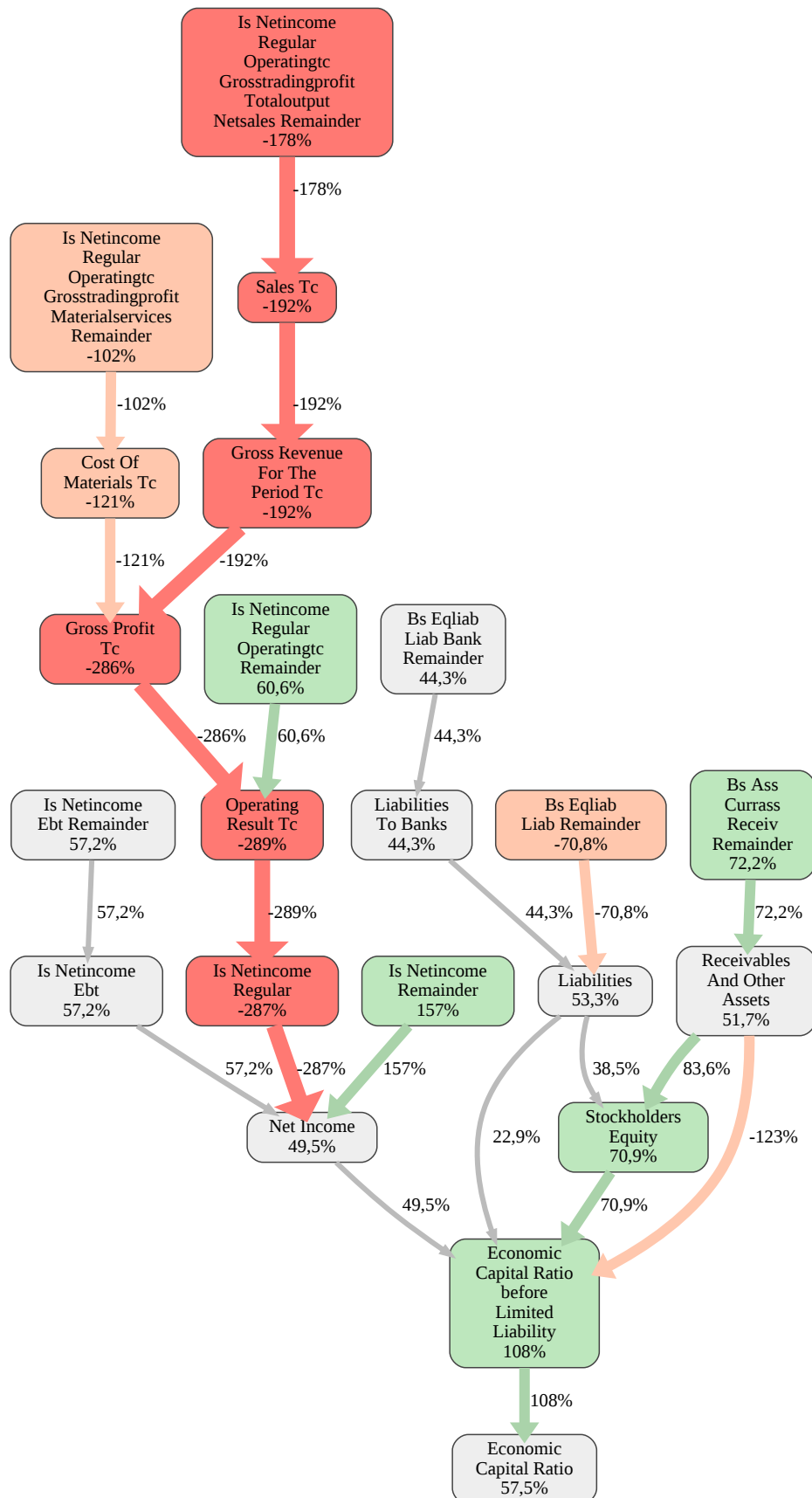




The relative strengths and weaknesses of Echterhoff Holding GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Echterhoff Holding GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 157% points. The greatest weakness of Echterhoff Holding GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 289% points.

The company's Economic Capital Ratio, given in the ranking table, is 159%, being 58% points above the market average of 102%.
