



The relative strengths and weaknesses of PORR Oevermann GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of PORR Oevermann GmbH Konzern compared to the market average is the variable *Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder*, increasing the Economic Capital Ratio by 101% points. The greatest weakness of PORR Oevermann GmbH Konzern is the variable *Bs Ass Currass Inventory Remainder*, reducing the Economic Capital Ratio by 1.066% points.

The company's Economic Capital Ratio, given in the ranking table, is 101%, being 1.00% points below the market average of 102%.
