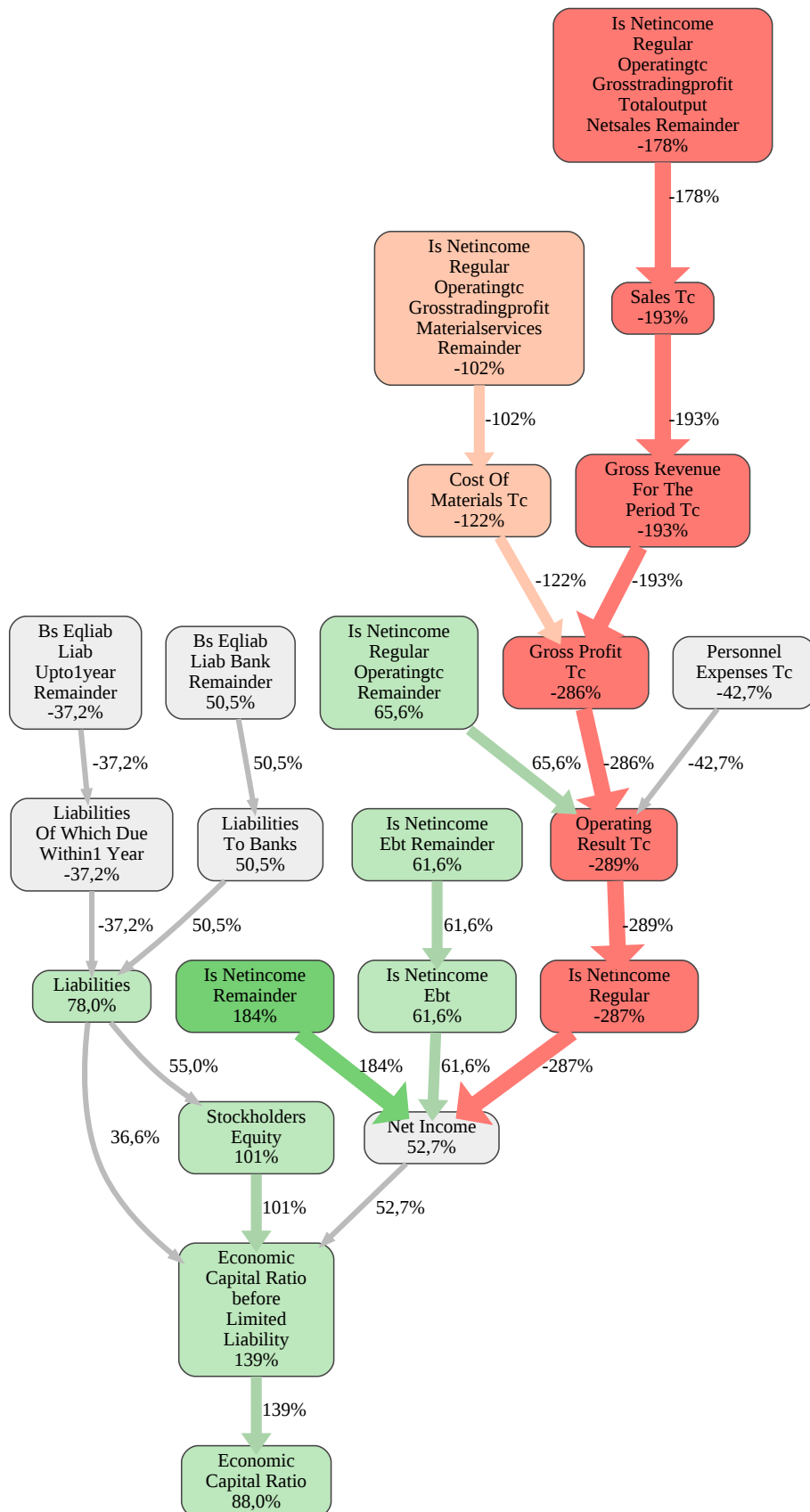




The relative strengths and weaknesses of Koop Bremsendienst GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Koop Bremsendienst GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 184% points. The greatest weakness of Koop Bremsendienst GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 289% points.

The company's Economic Capital Ratio, given in the ranking table, is 190%, being 88% points above the market average of 102%.
