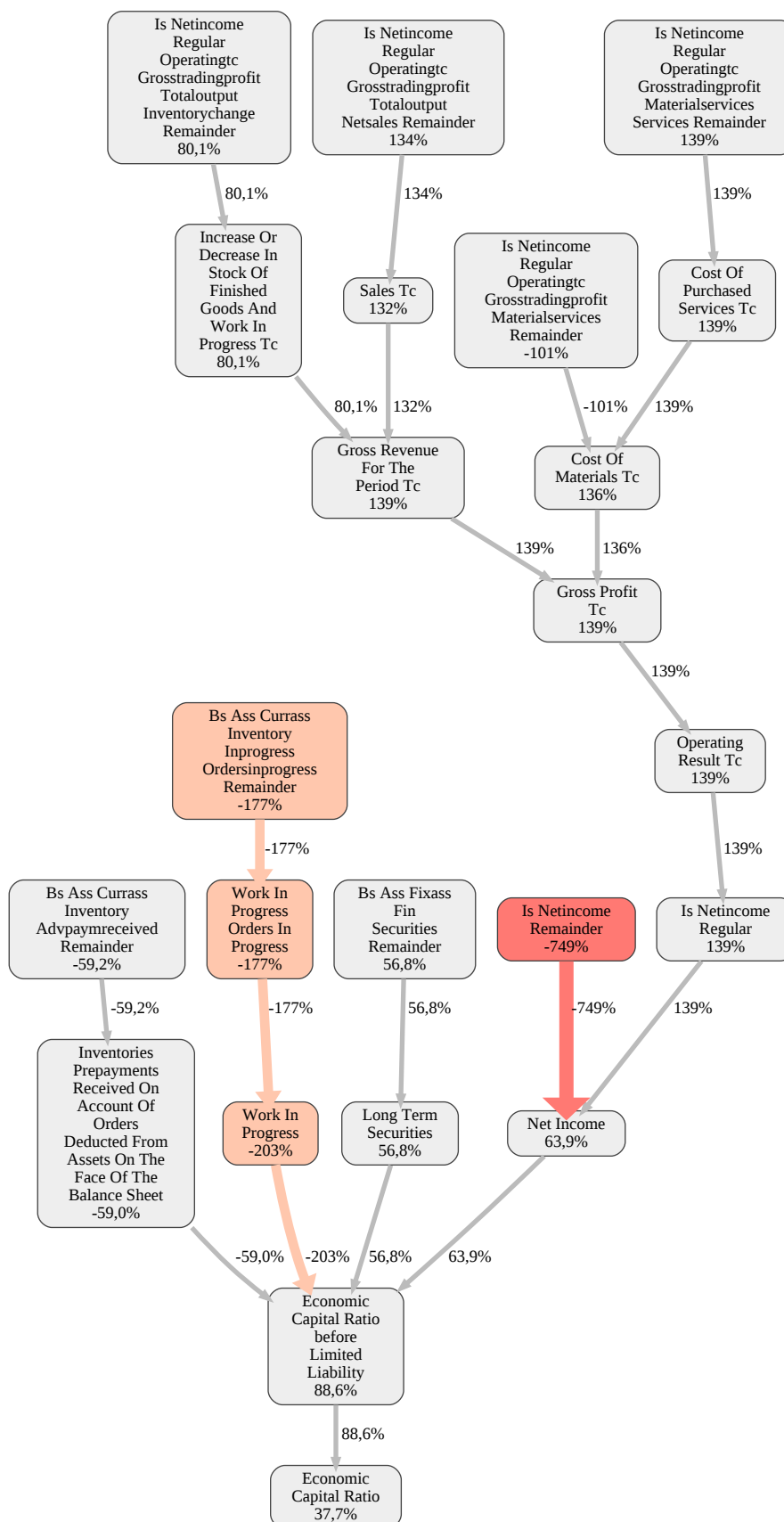




The relative strengths and weaknesses of Schrobsdorff Holding AG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Holding AG Konzern compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 139% points. The greatest weakness of Schrobsdorff Holding AG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 749% points.

The company's Economic Capital Ratio, given in the ranking table, is 139%, being 38% points above the market average of 102%.
