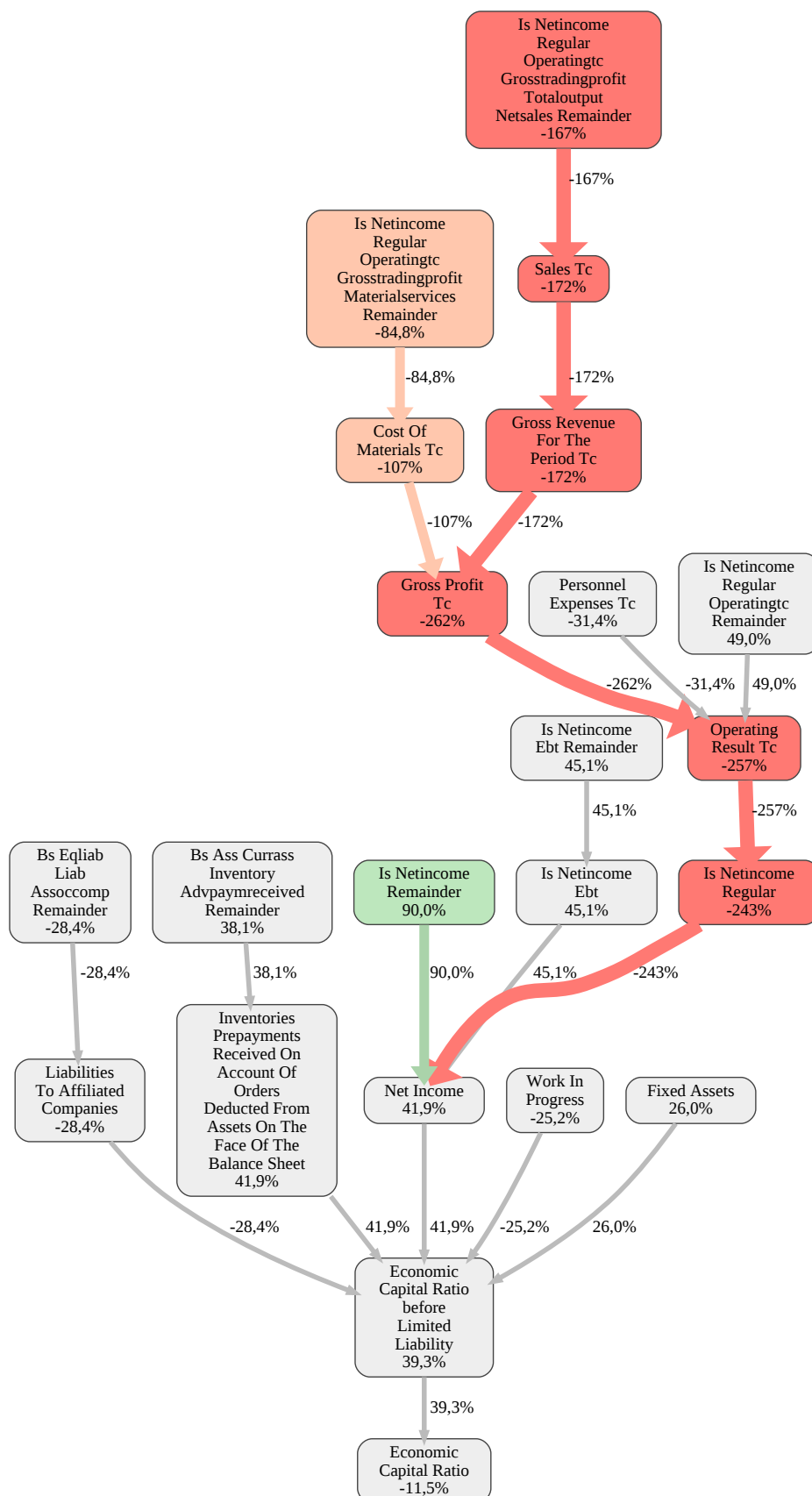




The relative strengths and weaknesses of Degewo Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Degewo Aktiengesellschaft compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 90% points. The greatest weakness of Degewo Aktiengesellschaft is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 262% points.

The company's Economic Capital Ratio, given in the ranking table, is 90%, being 11% points below the market average of 102%.
