The greatest strength of Ortwin Goldbeck Holding SE compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Ortwin Goldbeck Holding SE is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 420% points.

The company's Economic Capital Ratio, given in the ranking table, is 63%, being 37% points below the market average of 100%.
