The greatest strength of Amazing Energy Oil Gas Co compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 71% points. The greatest weakness of Amazing Energy Oil Gas Co is the variable Property, Plant and Equipment, reducing the Economic Capital Ratio by 67% points.

The company's Economic Capital Ratio, given in the ranking table, is -67%, being 131% points below the market average of 64%.
