

The relative strengths and weaknesses of INTERPUBLIC GROUP OF COMPANIES INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of INTERPUBLIC GROUP OF COMPANIES INC. compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 191% points. The greatest weakness of INTERPUBLIC GROUP OF COMPANIES INC. is the variable Cost of Goods and Services Sold, reducing the Economic Capital Ratio by 201% points.

The company's Economic Capital Ratio, given in the ranking table, is 95%, being 399% points above the market average of -304%.
