

The relative strengths and weaknesses of CMG HOLDINGS GROUP INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of CMG HOLDINGS GROUP INC. compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 313% points. The greatest weakness of CMG HOLDINGS GROUP INC. is the variable Cost of Goods and Services Sold, reducing the Economic Capital Ratio by 322% points.

The company's Economic Capital Ratio, given in the ranking table, is 135%, being 439% points above the market average of -304%.
