

The relative strengths and weaknesses of IZEA Worldwide Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of IZEA Worldwide Inc. compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 209% points. The greatest weakness of IZEA Worldwide Inc. is the variable Cost of Goods and Services Sold, reducing the Economic Capital Ratio by 119% points.

The company's Economic Capital Ratio, given in the ranking table, is 317%, being 621% points above the market average of -304%.
