

HARBOR DIVERSIFIED INC. Rank 2 of 10

The relative strengths and weaknesses of HARBOR DIVERSIFIED INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HARBOR DIVERSIFIED INC. compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 53% points. The greatest weakness of HARBOR DIVERSIFIED INC. is the variable Liabilities, Non-Current, reducing the Economic Capital Ratio by 13% points.

The company's Economic Capital Ratio, given in the ranking table, is 55%, being 32% points above the market average of 22%.
