

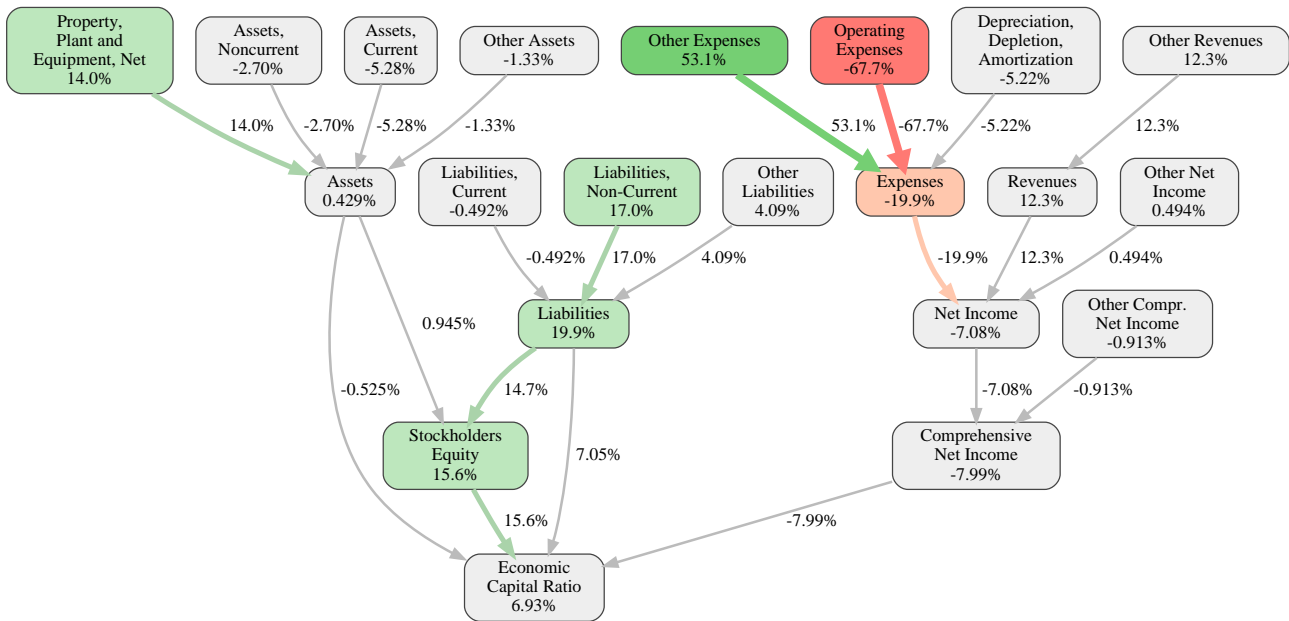

## JETBLUE AIRWAYS CORP

Rank 5 of 16





The relative strengths and weaknesses of JETBLUE AIRWAYS CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of JETBLUE AIRWAYS CORP compared to the market average is the variable Other Expenses, increasing the Economic Capital Ratio by 53% points. The greatest weakness of JETBLUE AIRWAYS CORP is the variable Operating Expenses, reducing the Economic Capital Ratio by 68% points.

The company's Economic Capital Ratio, given in the ranking table, is 55%, being 6.9% points above the market average of 48%.
