

ML Select Futures I LP Rank 29 of 120

The relative strengths and weaknesses of ML Select Futures I LP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ML Select Futures I LP compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 43% points. The greatest weakness of ML Select Futures I LP is the variable Revenues, reducing the Economic Capital Ratio by 13% points.

The company's Economic Capital Ratio, given in the ranking table, is 174%, being 40% points above the market average of 134%.
