

ML Select Futures I LP Rank 73 of 107

The relative strengths and weaknesses of ML Select Futures I LP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ML Select Futures I LP compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 18% points. The greatest weakness of ML Select Futures I LP is the variable Net Income, reducing the Economic Capital Ratio by 37% points.

The company's Economic Capital Ratio, given in the ranking table, is 122%, being 18% points below the market average of 140%.
