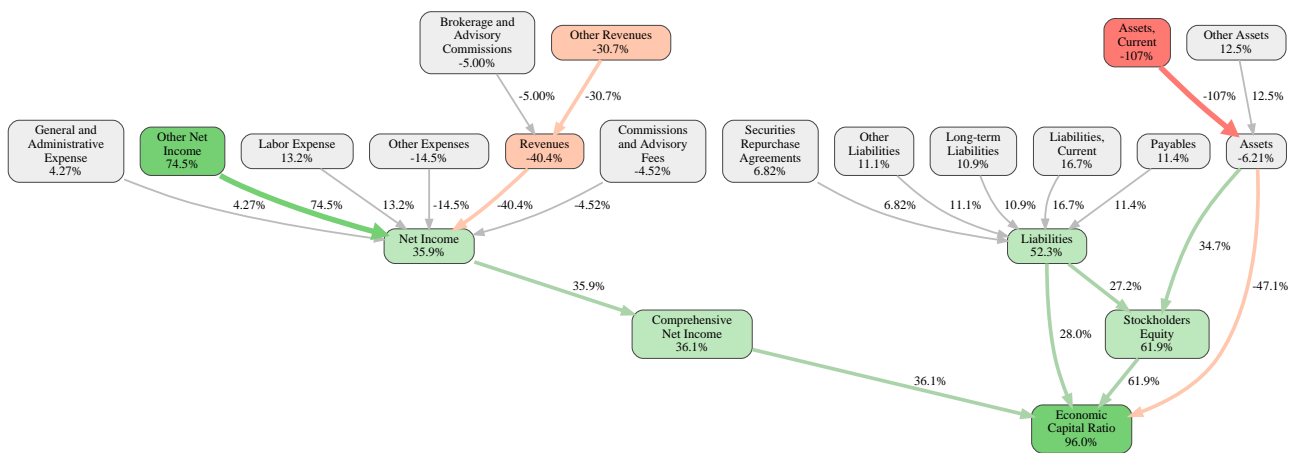

The relative strengths and weaknesses of MANAGED FUTURES PREMIER ENERGY FUND L.P. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MANAGED FUTURES PREMIER ENERGY FUND L.P. compared to the market average is the variable Other Net Income, increasing the Economic Capital Ratio by 74% points. The greatest weakness of MANAGED FUTURES PREMIER ENERGY FUND L.P. is the variable Assets, Current, reducing the Economic Capital Ratio by 107% points.

The company's Economic Capital Ratio, given in the ranking table, is 265%, being 96% points above the market average of 169%.
