


The relative strengths and weaknesses of GLOBAL DIVERSIFIED FUTURES FUND L.P. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GLOBAL DIVERSIFIED FUTURES FUND L.P. compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 70% points. The greatest weakness of GLOBAL DIVERSIFIED FUTURES FUND L.P. is the variable Net Income, reducing the Economic Capital Ratio by 199% points.

The company's Economic Capital Ratio, given in the ranking table, is 12%, being 157% points below the market average of 169%.
