Diversified 2000 Futures FUND L P Rank 48 of 85

The relative strengths and weaknesses of Diversified 2000 Futures FUND L P are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Diversified 2000 Futures FUND L P compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 38% points. The greatest weakness of Diversified 2000 Futures FUND L P is the variable Net Income, reducing the Economic Capital Ratio by 26% points.

The company's Economic Capital Ratio, given in the ranking table, is 153%, being 8.5% points above the market average of 145%.
