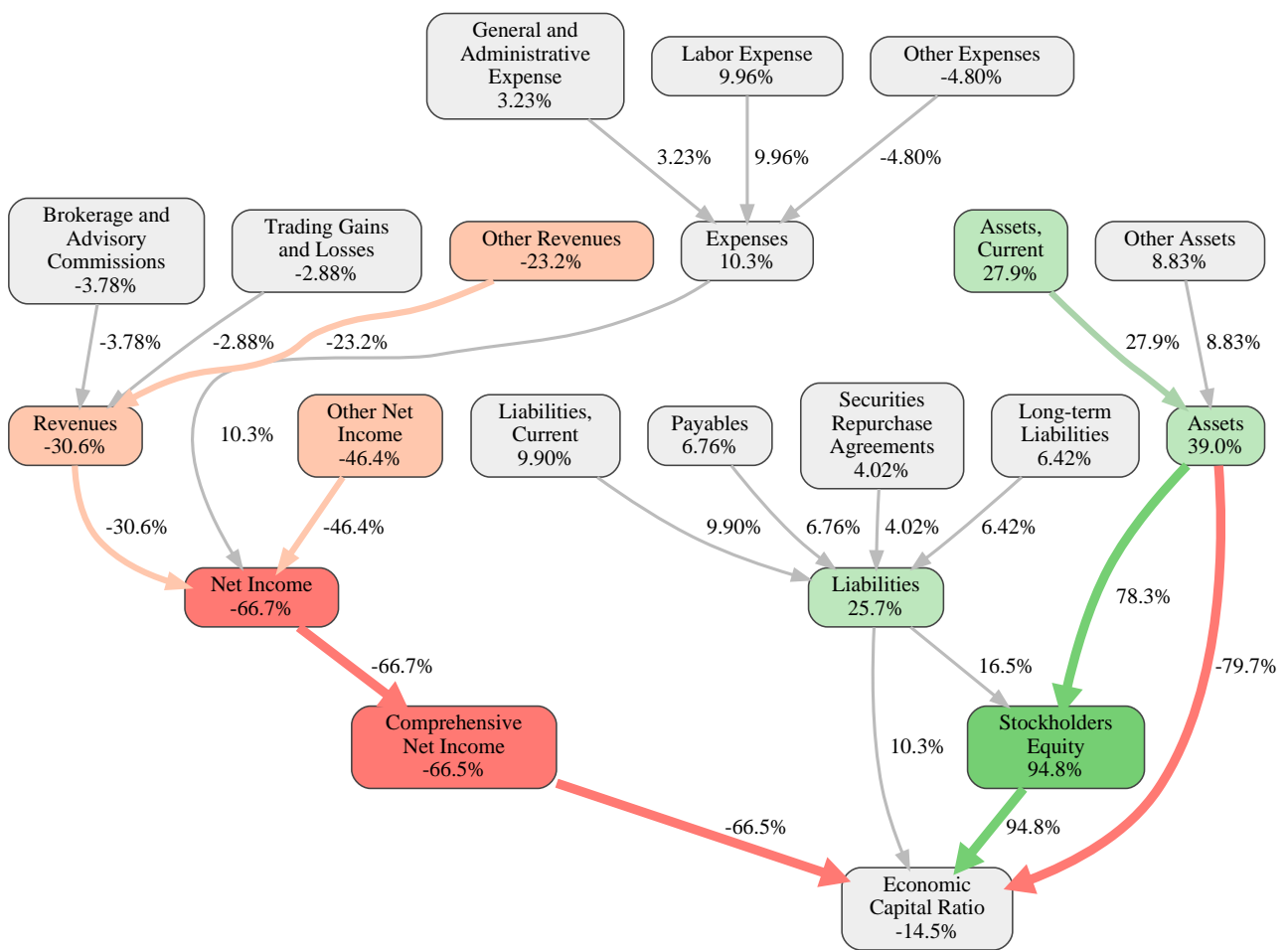

The greatest strength of MAN FRM MANAGED FUTURES STRATEGIES LLC compared to the market average is the variable Assets, Current, increasing the Economic Capital Ratio by 28% points. The greatest weakness of MAN FRM MANAGED FUTURES STRATEGIES LLC is the variable Net Income, reducing the Economic Capital Ratio by 67% points.

The company's Economic Capital Ratio, given in the ranking table, is 154%, being 14% points below the market average of 169%.
