




## GRANT PARK FUTURES FUND LIMITED PARTNERSHIP Rank 38 of 79











The relative strengths and weaknesses of GRANT PARK FUTURES FUND LIMITED PARTNERSHIP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GRANT PARK FUTURES FUND LIMITED PARTNERSHIP compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 30% points. The greatest weakness of GRANT PARK FUTURES FUND LIMITED PARTNERSHIP is the variable Net Income, reducing the Economic Capital Ratio by 38% points.

The company's Economic Capital Ratio, given in the ranking table, is 183%, being 19% points above the market average of 163%.
