

The relative strengths and weaknesses of INVESCO DB AGRICULTURE FUND are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of INVESCO DB AGRICULTURE FUND compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 100% points. The greatest weakness of INVESCO DB AGRICULTURE FUND is the variable Other Net Income, reducing the Economic Capital Ratio by 89% points.

The company's Economic Capital Ratio, given in the ranking table, is 110%, being 22% points below the market average of 132%.
