

## WisdomTree Continuous Commodity Index Master Fund Rank 19 of 80

The relative strengths and weaknesses of WisdomTree Continuous Commodity Index Master Fund are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WisdomTree Continuous Commodity Index Master Fund compared to the market average is the variable Other Net Income, increasing the Economic Capital Ratio by 40% points. The greatest weakness of WisdomTree Continuous Commodity Index Master Fund is the variable Other Assets, reducing the Economic Capital Ratio by 63% points.

The company's Economic Capital Ratio, given in the ranking table, is 297%, being 95% points above the market average of 202%.
