

INVESCO DB BASE METALS FUND Rank 38 of 80



The relative strengths and weaknesses of INVESCO DB BASE METALS FUND are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of INVESCO DB BASE METALS FUND compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 22% points. The greatest weakness of INVESCO DB BASE METALS FUND is the variable Net Income, reducing the Economic Capital Ratio by 28% points.

The company's Economic Capital Ratio, given in the ranking table, is 218%, being 17% points above the market average of 202%.
