

## Jefferies Financial Group Inc. Rank 54 of 73

The relative strengths and weaknesses of Jefferies Financial Group Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Jefferies Financial Group Inc. compared to the market average is the variable Financial Securities, increasing the Economic Capital Ratio by 78% points. The greatest weakness of Jefferies Financial Group Inc. is the variable Other Assets, reducing the Economic Capital Ratio by 63% points.

The company's Economic Capital Ratio, given in the ranking table, is 38%, being 127% points below the market average of 165%.
