

The relative strengths and weaknesses of GRANT PARK FUTURES FUND LIMITED PARTNERSHIP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GRANT PARK FUTURES FUND LIMITED PARTNERSHIP compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 57% points. The greatest weakness of GRANT PARK FUTURES FUND LIMITED PARTNERSHIP is the variable Net Income, reducing the Economic Capital Ratio by 123% points.

The company's Economic Capital Ratio, given in the ranking table, is 101%, being 65% points below the market average of 165%.
