## MAN AHL DIVERSIFIED I LP Rank 34 of 73



The relative strengths and weaknesses of MAN AHL DIVERSIFIED I LP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MAN AHL DIVERSIFIED I LP compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 62% points. The greatest weakness of MAN AHL DIVERSIFIED I LP is the variable Net Income, reducing the Economic Capital Ratio by 47% points.

The company's Economic Capital Ratio, given in the ranking table, is 180%, being 15% points above the market average of 165%.
