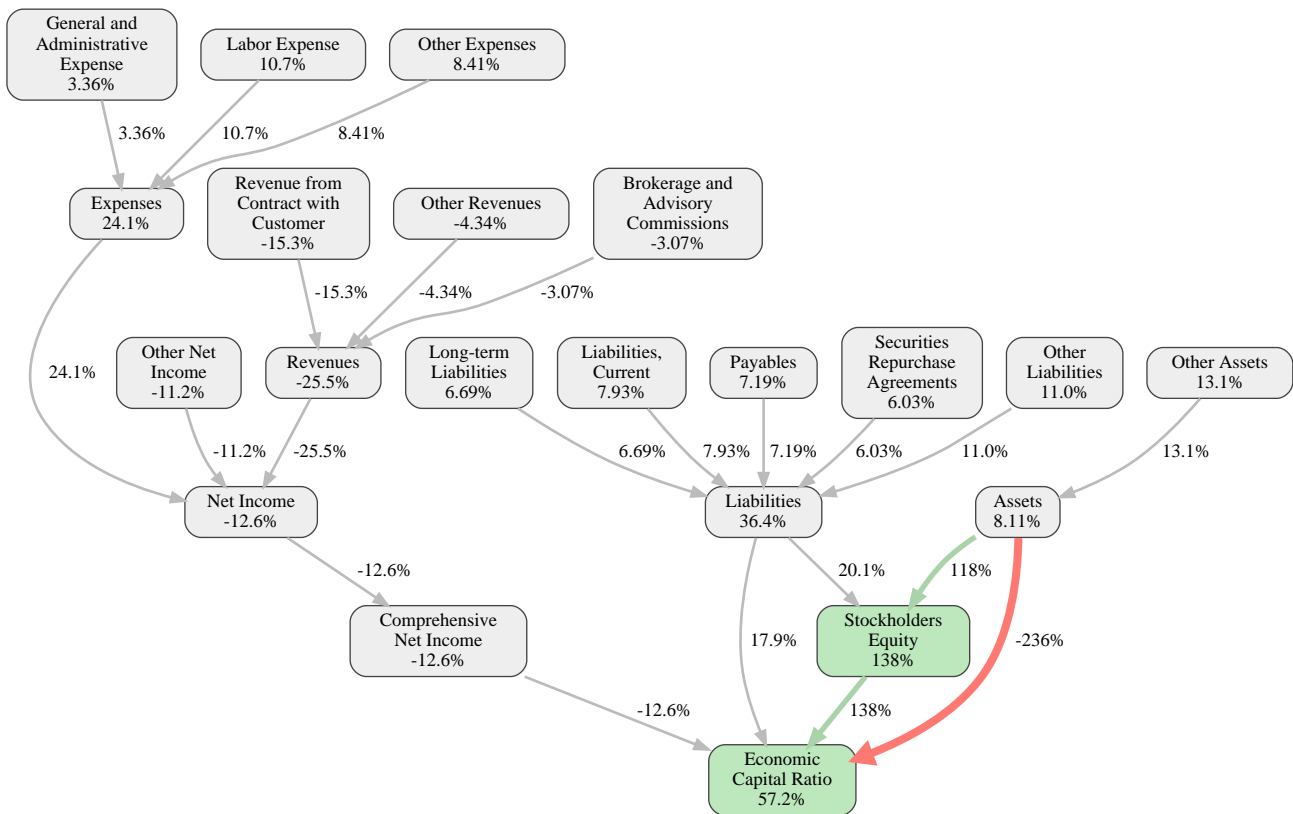

## Invesco CurrencyShares Swiss Franc Trust Rank 26 of 73



The relative strengths and weaknesses of Invesco CurrencyShares Swiss Franc Trust are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Invesco CurrencyShares Swiss Franc Trust compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 24% points. The greatest weakness of Invesco CurrencyShares Swiss Franc Trust is the variable Revenues, reducing the Economic Capital Ratio by 26% points.

The company's Economic Capital Ratio, given in the ranking table, is 222%, being 57% points above the market average of 165%.
