### Invesco CurrencyShares Euro Trust Rank 37 of 74



The relative strengths and weaknesses of Invesco CurrencyShares Euro Trust are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Invesco CurrencyShares Euro Trust compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 21% points. The greatest weakness of Invesco CurrencyShares Euro Trust is the variable Net Income, reducing the Economic Capital Ratio by 32% points.

The company's Economic Capital Ratio, given in the ranking table, is 217%, being 12% points above the market average of 205%.
