## INVESCO DB BASE METALS FUND Rank 11 of 74

The relative strengths and weaknesses of INVESCO DB BASE METALS FUND are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of INVESCO DB BASE METALS FUND compared to the market average is the variable Other Net Income, increasing the Economic Capital Ratio by 125% points. The greatest weakness of INVESCO DB BASE METALS FUND is the variable Other Assets, reducing the Economic Capital Ratio by 83% points.

The company's Economic Capital Ratio, given in the ranking table, is 378%, being 173% points above the market average of 205%.
