

ROGERS CORP Rank 6 of 75

The relative strengths and weaknesses of ROGERS CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ROGERS CORP compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 161% points. The greatest weakness of ROGERS CORP is the variable Other Net Income, reducing the Economic Capital Ratio by 107% points.

The company's Economic Capital Ratio, given in the ranking table, is 337%, being 300% points above the market average of 38%.
