

The relative strengths and weaknesses of NewHydrogen Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of NewHydrogen Inc. compared to the market average is the variable Other Net Income, increasing the Economic Capital Ratio by 547% points. The greatest weakness of NewHydrogen Inc. is the variable Liabilities, Current, reducing the Economic Capital Ratio by 1,222% points.

The company's Economic Capital Ratio, given in the ranking table, is 194%, being 156% points above the market average of 38%.
