



HEXCEL CORP DE Rank 55 of 83

The relative strengths and weaknesses of HEXCEL CORP DE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HEXCEL CORP DE compared to the market average is the variable Other Expenses, increasing the Economic Capital Ratio by 99% points. The greatest weakness of HEXCEL CORP DE is the variable Cost of Revenues, reducing the Economic Capital Ratio by 93% points.

The company's Economic Capital Ratio, given in the ranking table, is 82%, being 9.8% points above the market average of 72%.
