

The relative strengths and weaknesses of HOMELAND ENERGY SOLUTIONS LLC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HOMELAND ENERGY SOLUTIONS LLC compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 1,101% points. The greatest weakness of HOMELAND ENERGY SOLUTIONS LLC is the variable Cost of Revenues, reducing the Economic Capital Ratio by 1,218% points.

The company's Economic Capital Ratio, given in the ranking table, is 775%, being 703% points above the market average of 72%.
