

The relative strengths and weaknesses of Jacobs Engineering Group Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Jacobs Engineering Group Inc. compared to the market average is the variable Assets, Non-current, increasing the Economic Capital Ratio by 66% points. The greatest weakness of Jacobs Engineering Group Inc. is the variable Other Assets, reducing the Economic Capital Ratio by 29% points.

The company's Economic Capital Ratio, given in the ranking table, is 123%, being 73% points above the market average of 50%.
