


DATA PROCESSING 2021

LGBTQ Loyalty Holdings Inc. Rank 49 of 52











The relative strengths and weaknesses of LGBTQ Loyalty Holdings Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of LGBTQ Loyalty Holdings Inc. compared to the market average is the variable Other Liabilities, increasing the Economic Capital Ratio by 794% points. The greatest weakness of LGBTQ Loyalty Holdings Inc. is the variable Net Income, reducing the Economic Capital Ratio by 104% points.

The company's Economic Capital Ratio, given in the ranking table, is -295%, being 249% points below the market average of -46%.
