

## Alliancebernstein L P Rank 25 of 39



The relative strengths and weaknesses of Alliancebernstein L P are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Alliancebernstein L P compared to the market average is the variable Operating Expenses, increasing the Economic Capital Ratio by 27% points. The greatest weakness of Alliancebernstein L P is the variable Deposits and Payables to Customers, reducing the Economic Capital Ratio by 25% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 5.6% points below the market average of 100%.
