

The relative strengths and weaknesses of HENNESSY ADVISORS INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HENNESSY ADVISORS INC compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 124% points. The greatest weakness of HENNESSY ADVISORS INC is the variable Revenue from Contract with Customer, reducing the Economic Capital Ratio by 40% points.

The company's Economic Capital Ratio, given in the ranking table, is 218%, being 232% points above the market average of -14%.
