The relative strengths and weaknesses of THANKSGIVING COFFEE CO INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of THANKSGIVING COFFEE CO INC compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 239% points. The greatest weakness of THANKSGIVING COFFEE CO INC is the variable Other Expenses, reducing the Economic Capital Ratio by 259% points.

The company's Economic Capital Ratio, given in the ranking table, is 128%, being 57% points above the market average of 71%.
