

RiceBran Technologies Rank 18 of 37

The relative strengths and weaknesses of RiceBran Technologies are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of RiceBran Technologies compared to the market average is the variable Property and equipment, increasing the Economic Capital Ratio by 70% points. The greatest weakness of RiceBran Technologies is the variable Net Income, reducing the Economic Capital Ratio by 60% points.

The company's Economic Capital Ratio, given in the ranking table, is 109%, being 38% points above the market average of 71%.
