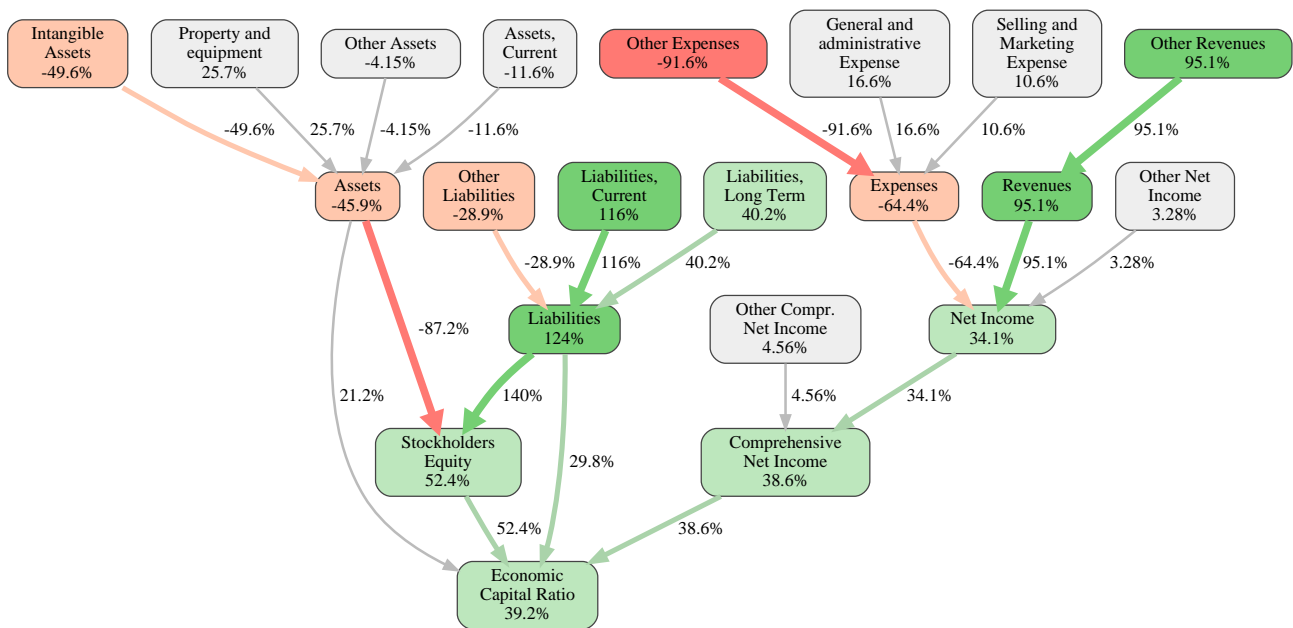

The relative strengths and weaknesses of BRIDGFORD FOODS CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BRIDGFORD FOODS CORP compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 116% points. The greatest weakness of BRIDGFORD FOODS CORP is the variable Other Expenses, reducing the Economic Capital Ratio by 92% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 39% points above the market average of 53%.
