The relative strengths and weaknesses of TEO FOODS INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of TEO FOODS INC compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 137% points. The greatest weakness of TEO FOODS INC is the variable Other Revenues, reducing the Economic Capital Ratio by 73% points.

The company's Economic Capital Ratio, given in the ranking table, is -327%, being 349% points below the market average of 22%.
