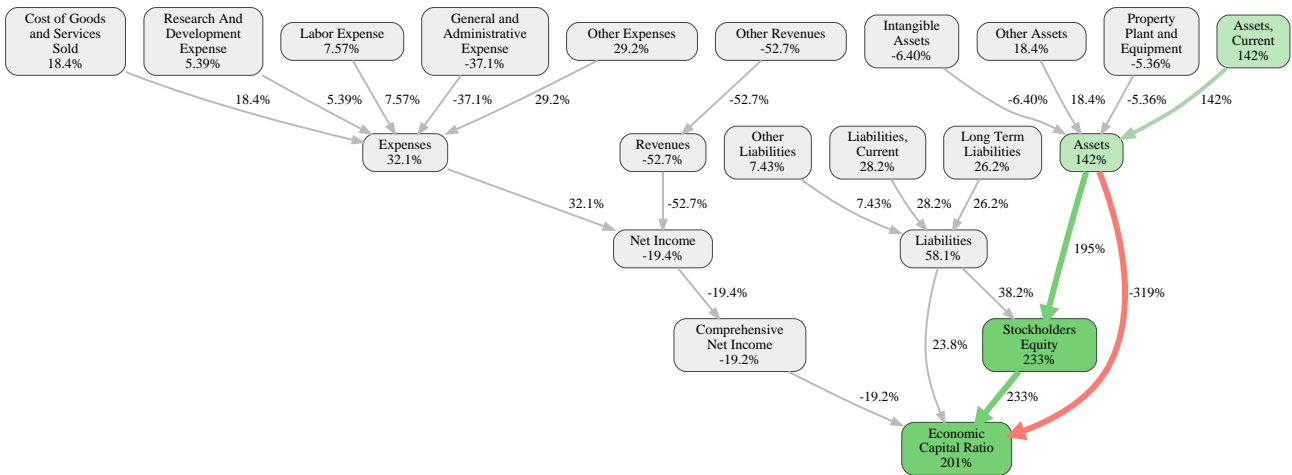

The relative strengths and weaknesses of CBA Florida Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of CBA Florida Inc. compared to the market average is the variable Assets, Current, increasing the Economic Capital Ratio by 142% points. The greatest weakness of CBA Florida Inc. is the variable Other Revenues, reducing the Economic Capital Ratio by 53% points.

The company's Economic Capital Ratio, given in the ranking table, is 234%, being 201% points above the market average of 32%.
