

The relative strengths and weaknesses of MAGELLAN HEALTH INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MAGELLAN HEALTH INC compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 178% points. The greatest weakness of MAGELLAN HEALTH INC is the variable Other Expenses, reducing the Economic Capital Ratio by 228% points.

The company's Economic Capital Ratio, given in the ranking table, is 102%, being 73% points above the market average of 29%.
