

The relative strengths and weaknesses of Acadia Healthcare Company Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Acadia Healthcare Company Inc. compared to the market average is the variable Property Plant and Equipment, increasing the Economic Capital Ratio by 71% points. The greatest weakness of Acadia Healthcare Company Inc. is the variable Long Term Liabilities, reducing the Economic Capital Ratio by 133% points.

The company's Economic Capital Ratio, given in the ranking table, is 80%, being 51% points above the market average of 29%.
