

The relative strengths and weaknesses of TRANSAMERICA ADVISORS LIFE INSURANCE Co are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of TRANSAMERICA ADVISORS LIFE INSURANCE Co compared to the market average is the variable Separate Account, Assets, increasing the Economic Capital Ratio by 27% points. The greatest weakness of TRANSAMERICA ADVISORS LIFE INSURANCE Co is the variable Separate Account, Liability, reducing the Economic Capital Ratio by 31% points.

The company's Economic Capital Ratio, given in the ranking table, is 6.5%, being 4.8% points below the market average of 11%.
