

The relative strengths and weaknesses of LINCOLN NATIONAL LIFE INSURANCE CO IN are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of LINCOLN NATIONAL LIFE INSURANCE CO IN compared to the market average is the variable Separate Account, Assets, increasing the Economic Capital Ratio by 19% points. The greatest weakness of LINCOLN NATIONAL LIFE INSURANCE CO IN is the variable Separate Account, Liability, reducing the Economic Capital Ratio by 21% points.

The company's Economic Capital Ratio, given in the ranking table, is 4.7%, being 7.5% points below the market average of 12%.
