The relative strengths and weaknesses of GLOBE LIFE INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GLOBE LIFE INC. compared to the market average is the variable Debt Securities, Available-for-sale, increasing the Economic Capital Ratio by 23% points. The greatest weakness of GLOBE LIFE INC. is the variable Liability for Future Policy Benefit, reducing the Economic Capital Ratio by 21% points.

The company's Economic Capital Ratio, given in the ranking table, is 11%, being 2.7% points above the market average of 8.6%.
