

GOLD RESOURCE CORP Rank 7 of 86



The relative strengths and weaknesses of GOLD RESOURCE CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GOLD RESOURCE CORP compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 117% points. The greatest weakness of GOLD RESOURCE CORP is the variable Other Expenses, reducing the Economic Capital Ratio by 59% points.

The company's Economic Capital Ratio, given in the ranking table, is 191%, being 277% points above the market average of -86%.
