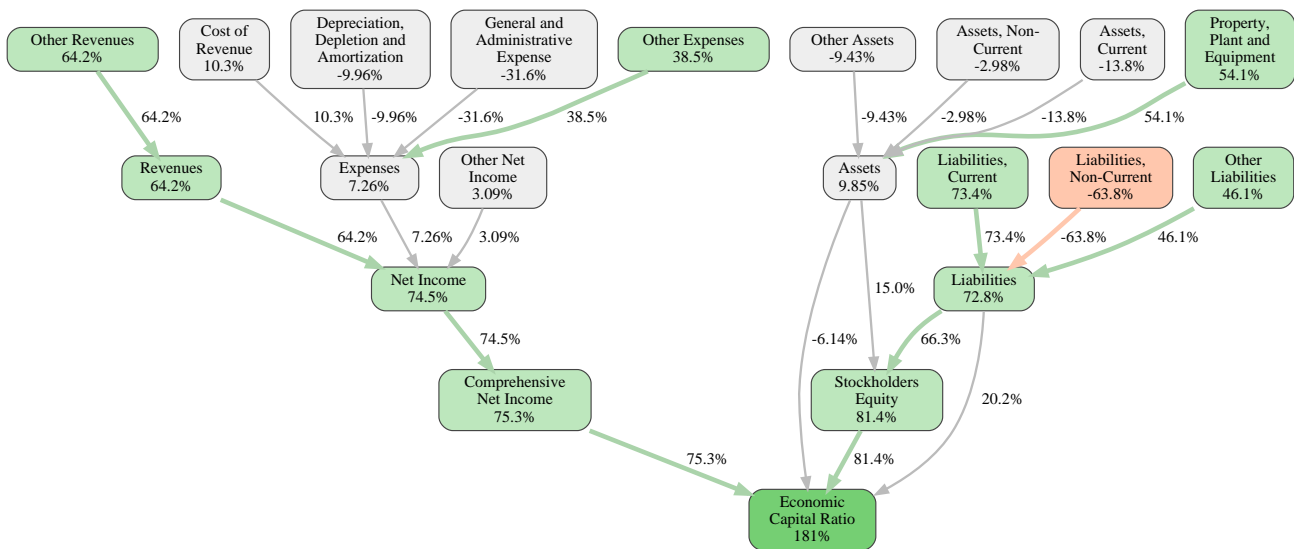

## CONSOL Coal Resources LP Rank 24 of 79



The relative strengths and weaknesses of CONSOL Coal Resources LP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of CONSOL Coal Resources LP compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 75% points. The greatest weakness of CONSOL Coal Resources LP is the variable Liabilities, Non-Current, reducing the Economic Capital Ratio by 64% points.

The company's Economic Capital Ratio, given in the ranking table, is 98%, being 181% points above the market average of -83%.
