The relative strengths and weaknesses of TGS International Ltd. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of TGS International Ltd. compared to the market average is the variable Goodwill, increasing the Economic Capital Ratio by 67% points. The greatest weakness of TGS International Ltd. is the variable General and Administrative Expense, reducing the Economic Capital Ratio by 29% points.

The company's Economic Capital Ratio, given in the ranking table, is 2.3%, being 85% points above the market average of -83%.
