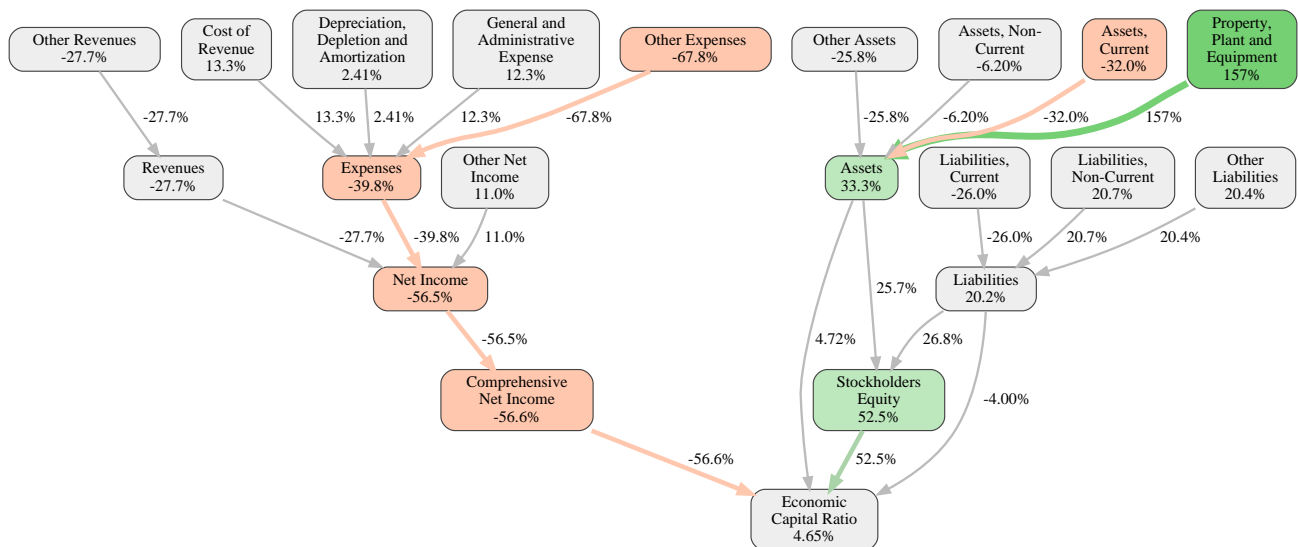

The relative strengths and weaknesses of BLUE EAGLE LITHIUM INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BLUE EAGLE LITHIUM INC. compared to the market average is the variable Property, Plant and Equipment, increasing the Economic Capital Ratio by 157% points. The greatest weakness of BLUE EAGLE LITHIUM INC. is the variable Other Expenses, reducing the Economic Capital Ratio by 68% points.

The company's Economic Capital Ratio, given in the ranking table, is -42%, being 4.7% points above the market average of -47%.
